# **Privacy Notice**

#### 1. Introduction

We are committed to protecting your privacy. This Privacy Notice explains how we collect, use, and protect personal data when you visit our website or engage with our HR consultancy services. - Any other personal data you choose to provide when contacting us

## 4. How We Use Your Personal Data

We use personal data to:

- Provide HR consultancy services to clients
  - Respond to inquiries and communicate with you
  - Improve our services and website
  - Comply with legal and regulatory obligations.

#### 5. Legal Basis for Processing

We process personal data under the following lawful bases:

- Contractual necessity: When processing is required to provide our services
- Legitimate interests: When processing supports our business operations without infringing your rights
- Legal obligations: Where processing is necessary to comply with legal or regulatory requirements
- Consent: Where you have given explicit consent for processing (e.g., marketing communications)

#### 6. Data Sharing and Transfers

We do not sell personal data. We may share data with:

- Trusted third-party service providers (e.g., IT support, cloud storage providers)
- Regulatory authorities, if required by law
- International clients, where necessary, ensuring compliance with data transfer safeguards (e.g., Standard Contractual Clauses for EU data transfers)

#### 7. Data Retention

We retain personal data only for as long as necessary for the purposes outlined above or as required by law. After this period, data is securely deleted or anonymised.
